Contract Terms and Conditions

1. Only compatible age groups and size shall play in the unit at the same time. Most significant injuries on jumps come from having large kids mixed in with smaller ones. The maximum number of riders of each group that should play in the unit at one time are:

UNIT SIZE	Children 8 & Under	Children 9 – 12	Teens	Adults
13' x 13'	7 – 8	5 – 6	3 - 4	3

2. All riders MUST REMOVE SHOES, JEWELRY, and GLASSES before playing in the Jump unit. No sharp objects are allowed in the unit. No excessive weight on the walls or netting is permitted.
3. To avoid neck and back injuries, FLIPS ARE NOT ALLOWED.
- ★ 4. CHILDREN'S SAFETY DEPENDS UPON YOU. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE UNIT, THE SAFETY OF ALL RIDERS IS YOUR RESPONSIBILITY. Initial
5. The operator should position themselves in close proximity to the entrance of the inflatable. Anyone who does not obey the rules after being warned should be told to exit the inflatable. Operators should understand that they are in control of the inflatable. Removing someone from the inflatable who is following the rules is important for all riders' safety.
6. Absolutely No "Silly String," gum, candy or other sticky substances are allowed on the unit. If upon return such cleaning is required, there will be a \$100.00 cleaning fee automatically imposed.
7. NO DIVING, ROUGH PLAY, WRESTLING, OR SHOIVING is allowed. Remember Have Fun, but Be Safe.
8. Do not operate this unit in winds that is excess of 20 M.P.H.
9. Do not operate this unit in rain or inclement weather.
10. Pick up all debris (Pinecones, sticks, etc...) from area inflatable will be placed. Do not inflate this unit without first securing it to the ground using all tethering connections.
11. Do not pound stakes into the ground without verifying gas & electrical locations.
12. SAFE OPERATION ACKNOWLEDGMENT: Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the unit rented. Lessee agrees to observe all safety precautions. Lessee also represents and warrants the safe return of the unit and hereby agrees to pay THREE THOUSAND DOLLARS (\$3000.00) if it is not returned. If unit is not returned on its due date and time, Lessee agrees to pay additional rental fees of \$200.00 per unit per day until the unit is returned, together with attorney's fees and related costs regarding the return of the unit.
13. The Lessee shall be in charge of the unit's operation, and is fully responsible for its operation as well as the return of the unit in good working order.
14. Lessee agrees to reimburse, indemnify, hold harmless and defend, at Lessee's expense, the Lessor, against all losses, liabilities, damage, injuries, penalties, demands, cost, attorney's fees, fines, claims, or settlements, including, without limitation, a bodily injury, death, property damage or damage arising out of the use, operation, maintenance or control of the equipment.
15. Lessee is responsible for the cleaning and disinfecting of **all** bodily fluids (kids – accidents) from the unit.

If the inflatable loses power, don't panic! Help the children exit the unit quickly, but do not scare them. Most Moonwalks have enough air in them to sink gently to the ground, making it tricky to walk, but providing a soft landing!
